STUDENT EMERGENCY FUND

Coming from a single-parent family, the student has been financially independent and got to support himself as early as three years ago by taking up part-time jobs on campus and teaching kids at tutorial centers.

Owing to the outbreak of COVID-19, he lost all his jobs since January 2020. This unforeseen financial difficulty sank him into deep despair to support his living, not to mention the extra spending on daily necessities such as masks and personal hygiene products.

Financial Arrangement for the University's Endowment

All endowments are invested in a Central Pool based on an investment policy approved by the University's Council. The objective is to provide, over time, a steady and sustainable distribution of funds to meet present and future expenditure. By incorporating environmental, social and governance considerations, the Central Pool invests in a wide range of assets managed by 70 professional investment managers to ensure risks are properly diversified and volatility is minimized. Alternatively, subject to prior agreement with the donor and on a case-by-case basis, the University may implement other investment instructions as prescribed by the donor.

Endowments are given the actual investment returns in full. Out of the investment return, a fixed payout, currently set at 3.5% p.a., based on the principal of the endowments, will be distributed for spending. Payout is made semi-annually and will commence immediately after the establishment of an endowment. In other words, spending of the endowment can begin without any waiting period for accumulation of investment return. Any return in excess of the payout will be earmarked against the respective endowment of the corresponding donor and reinvested in the Central Pool with the aim to make the principal keep up with inflation over time. This will help in maintaining an endowment's purchasing power. Furthermore, to insulate the endowment from prevailing adverse investment markets conditions, our University could provide temporary bridging finance when the accumulated and unspent investment return is insufficient for the payout, thus ensuring the continuity and stability of the payout.

Our University periodically carries out a review of its Endowment Policy. The intent is to increase the payout steadily in the future when sufficient undistributed return has been accumulated. Our University monitors spending and accumulated investment returns, in order to ensure the sustainability of the endowments.
